

Privacy Statement / Privacy Policy

The private company Vierboom Trucks B.V. (KvK. 30232689) places importance on protecting personal data. Vierboom Trucks therefore sees it as her responsibility to protect your privacy. On this page you will read what data is being collected while you are using our page, why this data is collected and how collecting this data improves the experience of our users.

Application

This statement applies on the following categories natural persons of whom Vierboom Trucks processes personal data:

1. (potential) customers;
2. visitors of the location of Vierboom trucks;
3. visitors of <https://www.vierboomtrucks.nl>
4. all other people contacting Vierboom Trucks or people of whom Vierboom Trucks is processing personal data.

Processing of personal data

Vierboom Trucks processes personal data that:

1. a person involved has personally (during a conversation or meeting), by phone, or digitally provided, like contact details and -dependable on the nature of the occasion other personal data;
2. have been generated during a visit of a person involved to the website of Vierboom Trucks, like the IP-adress, the browsing behaviour on the website (like data about the first visit, last visit and current visit, the viewed pages and in what way was navigated over the website);
3. Vierboom Trucks has derived from other sources, among which business social media platforms like LinkedIn, public business websites, like the trade register of the Kamer van Koophandel, the Kadaster, Rdw, like filled-in and needed contact details and other personal data;
4. have been provided by other organisations to Vierboom Trucks.

Purposes of processing personal data

Vierboom Trucks processes personal data for the following purposes:

1. carrying out an agreement with the customer;
2. setting up agreements and invoices;
3. meeting legal requirements, among which the Anti-Money Laundering and Anti-Terrorist Financing Act(Wwft);
4. improving product and service information and carrying out directed marketing activities;
5. keeping track of user statistics. User statistics of the office website supply information about the amount of visitors, duration of the visit and the clicking behaviour;
6. securing access to the office and protecting confidential data.

What personal data is being processed

Legal basis

Vierboom Trucks process personal data on grounds of the following legal bases:

1. consent of the person involved, which can always be withdrawn without it damaging the legality of the processing based on the consent given before the withdrawal;
2. carrying out things in the face of (with the goal of) accommodating a contract of sale or an agreement of commission to providing services;
3. legal requirements, for example based on the Wwft;
4. a justifiable interest.

Processors

Vierboom Trucks can bring in service providers (processors). Vierboom Trucks accommodates a processing agreement with these processors that meets the requirements that the General Data Protection Regulation (GDPR / NL: AVG) sets. Vierboom Trucks uses an IT department that manages and secures the IT-environment of the office.

Sharing personal data with third parties

Vierboom Trucks shares personal data with third parties when it is needed for carrying out an agreement of meeting legal requirements. By meeting legal requirements can be thought of reporting unusual transactions. Personal data is also shared with the cloudprovider and the IT-provider. Vierboom Trucks does not share personal data with third parties for commercial purposes.

Retention of data

Vierboom Trucks principally handles the following retention period:

1. paper dossier: at least 5 years;
2. digital dossier: at least 5 years;
3. (financial)administrative data: 7 years after registering this data.

Alterations in the privacy statement

Vierboom Trucks can always alter this privacy statement. These alterations will be published on the website of Vierboom Trucks.

Rights, questions and complaints

A person involved always has the right to request Vierboom Trucks to look at their personal data, rectify, delete, transfer, limit processing and to object against the processing of the data. A person involved can contact Vierboom Trucks concerning this.
